Contract Specifications

a) Ref Price A - Description	" ELECTRICITY-SPP-SOUTH HUB-REAL TIME " means that the price for a Pricing Date will be that day's Specified Price per MWh of electricity for delivery on the Delivery Date, stated in U.S. Dollars, published by the SPP at https://marketplace.spp.org/web/guest/lmp-by-location under the headings "Marketplace Portal " or any successor headings, that reports prices effective on that Pricing Date.
b) Ref Price A - Pricing Date	Each day that prices are reported for the Delivery Date
c) Ref Price A - Specified Price	Average of LMPs for all hours, CPT, that are not ending 0700-2200 CPT
d) Ref Price A - Pricing calendar	SPP
e) Ref Price A - Delivery Date	Contract Period
Final Payment Date	The eighth Clearing Organization business day following the Last Trading Day
