Final Settlement	In respect of final settlement, the Floating Price will be a price in USD and cents per metric tonne based on the average of the mean of the “Bid” and “Ask” quotations appearing in the “Argus Biofuels” report under the heading “RED hydrotreated vegetable oil (HVO)” for “HVO fob ARA range (Class II)” for each business day (as specified below) in the determination period.
