Where a trade account meets or exceeds the Volume Threshold Levels as set out in the below table, the account must be identified to the Exchange as per the Exchange's Ownership and Control Reporting requirements (see [Here](#) for the OCR requirements).

The Exchange will continue to accept voluntary submissions of Volume Threshold Account reporting of 50 contracts or greater per day during the earlier periods noted below.
