CLEARING & MARGINING /

ICE Clear U.S. is the clearinghouse for ICE Futures U.S. and for Russell index futures on ICE. Clearing through ICE Clear U.S. offers:

- Increased capacity of ICE Clear U.S. including the implementation of Post Trade Management System (PTMS), and improved two-way FIXML interface.
- Block, EFP, cross-trade and Trade at Settlement (TAS) capabilities. Electronically executed TAS trades available for futures contracts on ICE.

Eligible clearing member firms and market professionals can cross-margin Russell index futures contracts with positions cleared by OCC.

Margin requirements for the cross-margin account will be based on the net risk of the positions as if they were in one portfolio. Cross-margining is available to the proprietary accounts of clearing firms or affiliates of ICE Clear U.S. and OCC, and qualified market professionals.
