### CHANGE IN MARGIN RATES

#### Summary

This Information Memo notifies Members that NYSE Liffe U.S.'s (the "Exchange") clearing service provider will change customer margin levels effective trade date January 29, 2013.

- 1.1 Effective trade date January 29, 2013, the Exchange's clearing service provider will change customer margin levels for 100 oz. Gold Futures, 33.2 oz. mini-sized Gold Futures, 5,000 oz. Silver Futures, and 1,000 oz. mini-sized Silver Futures, as well as all the mini MSCI Index Futures. Customer margin rates for all other exchange products are unchanged.
